6. Signage Proposal **Mark O.** Approved

Mark O. showed us designs using the official UU symbol (U cupping a candle) and asked us about the color choices, which are not going to affect the price. He has worked out a number of details for all of the signs. We all liked that very much.

We walked outside around the property to determine the best placement of signage. We'll have two double-sided, "enter" signs (which may also say exit where needed). One will be on Fairhope Avenue opposite to the existing sign and near the cypress tree. Another will be at Bishop Road. In addition, we will have a large, double-sided, very sturdy, FUF sign to sit perpendicular to the back of the building facing Fairhope Ave. We're also asking for two "Welcome" signs to be affixed on either side of the portico at the entrance. **Mark O.** will get the quotes for us, working with the estimate of \$2,000.00.

Nick moved, **Maggie** seconded, and the motion passed.

In addition, **Mark O.** presented to the board a beautiful, framed piece of his art about FUF. We graciously accepted it, and we congratulated **Mark O.** on his art. We will find a good place to display it, and **Irene** may choose to announce it and show it to the congregation on a Sunday morning.

7. Pantry **Nick** Discussion/proposal next month 5/23
We want to make more people aware of the pantry, and how often we fill it. Could we ask other grocery stores if they have a small quantity of food to donate? **Jeanine** and **Mark O.** have ideas about an ongoing member event to swap produce for items that can be donated to the pantry -- for those who grow gardens with an overflow of produce, and for those members who need produce, who can then contribute nonperishables to the pantry by "paying it forward." No decision was made, and **Jeanine** will write this up more clearly.

Also, **Maggie** will ask her husband, **Don**, if he can have to have a proposal for the next meeting about how can we expand our outreach.

8. Pi Day Report **Mark P. & Maggie** motion passed TBA
Maggie noted other events going on in Fairhope, especially the Arts & Crafts Festival, are possibly interfering with Pi Day attendance. We will check other local events around that time. Suggestions include: perhaps increase the price of the slice, and to have whole pies to sell as well. We voted to keep doing Pi Day; details TBA.
Maggie moved to continue it, **Phillip** seconded, and the motion passed.
